Rep. Rogers Introduces Legislation Expanding Chiropractic Services to Military Beneficiaries *Chiropractic Profession Urged to Enlist Support from Local Members of Congress*

U.S. Rep. Mike Rogers, R-Ala., has re-introduced legislation that would extend chiropractic health care services to U.S. military retirees, dependents and survivors as part of the TRICARE program. If signed into law, HR 484, the [*Chiropractic Health Parity for Military Beneficiaries Act*](#), would require the Secretary of Defense to develop a plan to allow any beneficiary covered under TRICARE to select and have direct access to a doctor of chiropractic. Dear Congressman Childers:

Chiropractic care is a proven and cost-effective health care choice. Today, there are more than 60,000 doctors of chiropractic practicing in the United States and in excess of 30 million chiropractic patients.

In recent years, in recognition of the value and benefits of chiropractic care, Congress has passed, and the President has signed into law, legislation establishing a permanent chiropractic care benefit for both active duty military personnel and veterans. Nevertheless, more needs to be done to overcome barriers to chiropractic care and ensure that doctors of chiropractic are integrated fully in Federal health care programs, particularly those aimed at providing care to our former military service personnel and their loved ones.

With this in mind, Rep. Mike Rogers (R-AL-3) sponsored H.R. 484, legislation to take the next step toward ensuring that all of Americas current and former military service personnel, and their families, that are in need of chiropractic care have access to the chiropractic services they need and deserve. This legislation will direct the Secretary of Defense to develop a comprehensive plan to provide chiropractic care services and benefits for all covered beneficiaries under the TRICARE program, to include military dependents, retirees and survivors.

I look forward to hearing from you on this important matter. Thank you for your consideration.

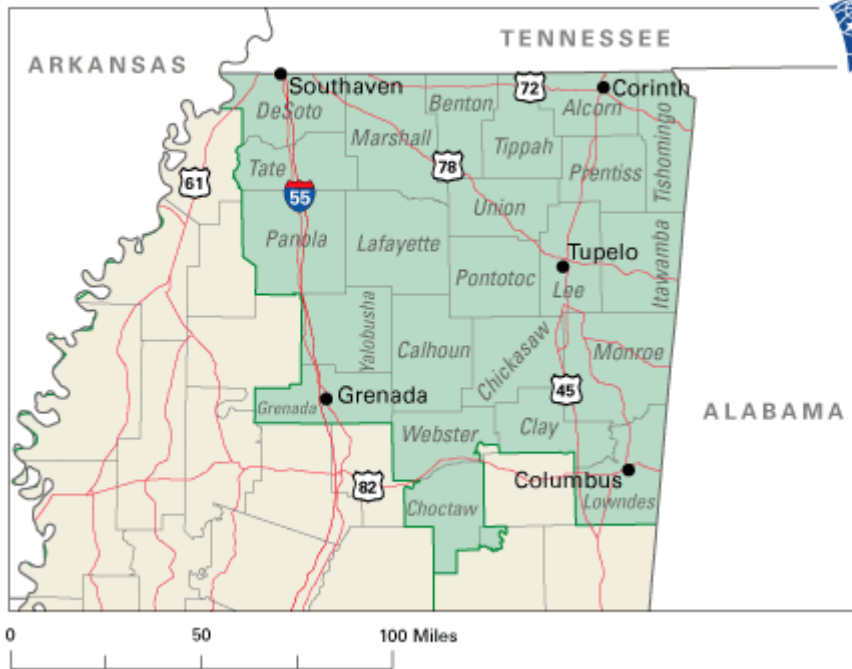
